

## AUDACITY, THEME OF THE 2018 EDITION OF “A PHOTOGRAPHER FOR EURAZEO” COMPETITION

For the competition’s ninth edition, the jury has selected the following theme: **“AUDACITY.”**

Photographers are invited to delve into their imagination and offer their interpretation of audacity in any field of photography. Eurazeo’s competition covers all professional photographers - known, unknown, emerging, visual artists, photojournalists, landscape, portrait - as well as photography students.

Care should be taken to present a coherently structured photo series that reflects a personal and committed vision. The photographs of short-listed submissions will be presented to an eleven-member jury largely comprising professionals from the world of photography and Eurazeo representatives.
